During the party the kids will play and participate in activities such as games, gymnastics, trampoline, bounce house, rope climbing and more! What is now the parent waiting area turns into the birthday party area. We will have birthday party decorations that include table covers, plates, silverware, and cups. If you wish to bring your own special decorations you are welcome to do so! You can bring balloons, piñatas, and whatever party decorations you wish to have. You can also bring games and we are open to special requests (if we can make it happen we will try our best to accommodate your requests)! Food and drinks is not provided by the gym so please bring the food, drinks, and the cake.

#### Birthday Party Rules / Policies

1. All participants must have a signed waiver before entering gym.
2. Birthday Party must be paid in advance.
3. No food or drinks are allowed in the gym area.
4. Please do not bring items of value into the gym. **Sarasota Gymnastics Academy** is not responsible for lost or stolen items.
5. No shoes allowed in the gym area. Cubbies are provided to keep all items.
6. No throwing foam pit cubes out of the pit area.
7. No throwing or pushing anyone into the pit.
8. Only one participant allowed on the trampoline at a time.
9. Do not attempt skills above your current ability.
10. No flips on or off of the trampoline.
11. No diving head first into loose foam pit.
12. No adjusting or re-adjusting of any equipment.
13. **The party MUST be completely done by the hour specified. Late fee of \$15 for every 15 min will apply.**

It is further warranted that such entry into the SGA for observation or use of any facilities or equipment or participation in such affiliated program constitutes an acknowledgement that such premises and all facilities and equipment thereon and such affiliated programs have been inspected and carefully considered and that the undersigned finds and accepts same as being safe and reasonably suited for the purpose of such observation, use, or participation. **IN FURTHER CONSIDERATION OF BEING PERMITTED TO ENTER THE SGA FOR ANY PURPOSE, INCLUDING BUT NOT LIMITED TO OBSERVATION OR USE OF FACILITIES OR EQUIPMENT, OR PARTICIPATION IN ANY PROGRAM AFFILIATED WITH THE SGA, WITHOUT RESPECT TO LOCATION, THE UNDERSIGNED HEREBY AGREES TO THE FOLLOWING: THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the SGA,** its directors, officers, employees, and agents (hereinafter referred to as "releasees") from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefor on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in, upon, or about the premises or any facilities or equipment therein, or participating in any program affiliated with the SGA, without respect to

location. THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in, upon, or about the SGA premises or in any way observing or using any facilities or equipment of the SGA or participating in any program affiliated with the SGA whether caused by the negligence of the releasees or otherwise. THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE due to negligence of releasees or otherwise while in, about, or upon the premises of the SGA and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with the SGA. THE UNDERSIGNED further expressly agrees that the forgoing RELEASE, WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the State of Florida and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements, or inducement apart from the foregoing written agreement have been made.
