This high energy, very active camp is open to all gymnasts, recreational, and team. The focus is on proper gymnastics progression: to develop skill in a safe and fun environment. The training is on all apparatus, floor exercise, balance beams, bars, vault, plus a 30 ft tumble track, multiple above ground resi-pits, bounce house, climbing rope. Skill progression equipment is also incorporated to develop strength and coordination. Proper gymnastics attire is required. Long hair must be tied. No Jewelry. All instructors are U.S.A. Gymnastics Certified.

Full day is 9:00 A.M.-4:00 P.M./FREE 8:00 A.M. drop-off and late pick up allowed until 5:00 P.M. **Half day** is 9:00 A.M. – 12:30 P.M.

Cost: Full day \$35.00 per day S.G.A. members / \$45.00 per day non-members **Half day** \$25.00 per day S.G.A. members / \$35.00 per day non-members. Full day campers train gymnastics from 9:00 A.M. – 12:30 P.M. then the rest of the day is filled with fun activities, games, and crafts. **Please bring lunch, change of clothes, snacks and/or money for snacks.** If you are choosing to do half day, please make sure you pick up your child at 12:30. Late pickup is not provided with half day. If you must pick child up late, you must pay for full day camp. You can become an S.G.A. member for \$40.00 - annual membership.

Space is LIMITED to 20 campers per day.

Costs: Full day camp is \$35.00, for the S.G.A. members, starting from 9:00A.M. to 5:00P.M., drop off is allowed from 8:00A.M. pickup is allowed as late as 5:00P.M. Half day camp is \$25.00 starting from 9:00A.M. to 12:30P.M. Early and late drop-off is not offered with half day camp. If camper comes early or stays late, the undersigned agrees to pay the full camp day price of \$35.00. Annual membership costs \$40.00. If participant wishes to participate without becoming a member of S.G.A. the non-member camp cost is \$45.00 for full day and \$35.00 for half day. Payment is due prior to attending camp. If camp is not paid, the S.G.A. has the right to contact, send bills to, and e-mail the participant or their legal guardian/parent. The S.G.A. has the right to act to collect the debt owed, including taking legal action to pursue payment of debt that is owed.

RELEASE & WAIVER OF LIABILITY AND INDEMNITY AGREEMENT: In consideration for being permitted to utilize the facilities, services, and programs of Sarasota Gymnastics Academy, from here on referred to as the SGA, for any purpose, including but not limited to observation or use of facilities or equipment, or participation in any program affiliated with the SGA, without respect to location, the undersigned, for himself or herself and any personal representatives, heirs, and next of kin, hereby acknowledges, agrees and represents that he or she has, or immediately upon entering or participating will inspect and carefully consider such premises and facilities or the affiliated program. THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the SGA, its directors, officers, employees, and agents (hereinafter referred to as "releasees") from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefor on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in, upon, or about the premises or any facilities or equipment therein, or participating in any program affiliated with the SGA, without respect to location.

THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in, upon, or about the SGA premises or in any way observing or using any facilities or equipment of the SGA or participating in any program affiliated with the SGA whether caused by the negligence of the releasees or otherwise.

THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE due to negligence of releasees or otherwise while in, about, or upon the premises of the SGA and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with the SGA.

THE UNDERSIGNED further expressly agrees that the forgoing RELEASE, WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the State of Florida and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements, or inducement apart from the foregoing written agreement have been made.
